



**Chester City Council Meeting
Special Called Meeting**
Monday, March 5, 2018, 4:00 p.m.

MINUTES

Present: Mayor Pro Tempore Annie Reid; Council Members Betty Bagley, Angela Douglas, Linda Tinker, Susan Kovas, Carlos Williams and William King; Interim Administrator Carla Roof and Payroll Clerk/Interim Clerk to Council Sylvia Young.

Absent: Mayor George Caldwell and Council Member William Killian.

Call to Order: Mayor Pro Tempore Reid called Council meeting to order at 4:00 p.m.

Prayer: Councilwoman Douglas led in prayer.

Pledge of Allegiance: Mayor Pro Tempore Reid and Council recited the Pledge of Allegiance.

EXECUTIVE SESSION:

Mayor Pro Tempore Reid stated that Council needed to convene into Executive Session to discuss a Legal Matter – Opioid Class Action Lawsuit and Contractual Matter – Administration Department.
