CITY COUNCIL MEETING - 6:30 P.M.

I. CALL TO ORDER

The meeting was called to order at 6:32 p.m. by Mayor Stringfellow. Roll call, quorum established.

II. PRAYER

Councilman Carlos Williams led Council in prayer.

The American Rescue Plan Act of 2021 - City Administrator Jackson informed Council of the stimulus funds approved by Congress that will be coming to the City of Chester. The funds will be issued by the State of South in two (2) payments. She recommended opening a separate bank account for the funds when they are issued.

Chester County Historical Society – Placement of 10 pounder Gun and Carriage – City Administrator Jackson discussed the letter from the Historical Society to place the gun and carriage in the museum in the City.

Approval of 2021 – 2022 Budget Calendar – City Administrator Jackson presented the budget calendar to Council - Upon motion made by Councilwoman Reid and seconded by Councilwoman Kovas, Council voted [6-Mayor Stringfellow, Council Members Carlos Williams, Angela Douglas, Susan Kovas, Annie Reid, and Robbie King-Boyd] for the approval of the 2021-2022 Budget Calendar. Opposes – None.

Affected Homes in Joe Collins Drainage Project – SC Rural Infrastructure Authority Grant Update – City Administrator Jackson stated that a grant has been submitted to improve the drainage.

Downtown Beautification Project (scheduled cleanup and flowers) – Request for the Public Works Committee to look at the schedule of the routes to more attentive to the downtown area, and the Frank Connor Park. Council needs to see improvement as stated by the Mayor.

Citizens Review Board (Moving forward with appointments and academy/classes) - Requested submission of the names for the Citizen Review Board.

Jeff Brown Complex (Request for use of complex – Softball for Girls) Facilities - The Mayor received a request to use the Jeff Brown complex for girl softball team to practice if the complex is up to par beginning in April. Discussion concerning an ordinance for the usage of the ball fields and staffing.

Recreation Plans moving forward (Pool preparation and summer outdoor activities) – Programs and physicals to participate as events are being planned. The meeting was called to order at 6:03 p.m. by Mayor Stringfellow. Roll call, quorum established.

IV. NEW BUSINESS

Discussion of Lifting Covid-19 Restrictions - RE: Outdoor Activities within the City

Mayor Stringfellow discussed the Jeff Brown softball field to be used for practices and Hog on the Hill event. A new ordinance was created to cover outdoor activities and facilities such as Parks, Fields, and the back lot. The request was made by City Administrator Jackson as requested for food truck vendors in downtown. Also, Attorney Edwards stated that CDC guidelines must be followed at all outdoor facilities. Councilwoman Reid stated that there should be a Covid release or waiver form for these outdoor activities. Mayor Stringfellow discussed the enforcement of the recommended ordinance and possible citations. The recommendation is to also check the CDC website for guidelines and make available to the public events. Also, signage be placed at the facilities. The Mayor also recommended coming up with an agreement regarding other expenses incurred and negotiate fees.

Upon motion made by Councilwoman Reid and seconded by Councilwoman Campbell Council voted to approve Ordinance No. 2021-03 [5 - Mayor Stringfellow, Councilwoman Kovas, Campbell, King-Boyd, Reid]; Opposes – none.

Upon motion made by Councilwoman Kovas and seconded by Councilwoman Campbell, Council voted to approve Hog on the Hill event [5 - Mayor Stringfellow, Councilwoman Kovas, Campbell, King-Boyd, Reid]; Opposes – none.
