Public Works – Discussion took place concerning by Councilwoman Reid concerning the communities and neighborhoods to have knowledge when there is construction taking place for them to prepare in case of the loss of power or roadblock for detours. Director Reggie McBeth stated hat sometimes he is not aware of construction projects, but will try to get information prior to projects.

Parks and Recreation – Director of Parks and Recreation Chris White, the Virtual Parade requesting videos from Council, the Virtual Christmas Tree Lighting can be seen on Facebook Live and the Return of Santa and Tour of Lighted Downtown Chester, businesses to decorate and light up the stores. I. CALL TO ORDER

The meeting was called to order at 6:31 p.m. by Mayor Stringfellow. Roll call, quorum established.

II. PRAYER

Councilwoman Reid led Council in prayer.

IV. NEW BUSINESS

Discussion on YMCA Closing and Strategies to Maintain YMCA Recreational Opportunities in the City and County Ordinance – Mayor Stringfellow began the discussion. Councilwoman Kovas and Councilwoman Campbell attended a meeting of the local YMCA Board of Directors who want to close the YMCA. Updates were given by the Regional Director, Curtis Lee. Some concerns were the leaks of the roof, new dressing rooms, but save the pool. The membership has dropped from 700 to 500 member. A partnership with MUSC, the County or the school district maybe a possibility. Director Wessinger spoke with the School Board and the County.

Councilwoman Kovas stated that funds will need to be raised for the roof and renovations of the bathrooms. Director Reggie McBeth made an assessment of the building, including the roof and other related repairs. The 500 members pay memberships and that money should stay in the Chester community. Councilwoman Campbell stated that a solution would be to create a community partnership. Mayor Stringfellow wanted to know why the funds from Chester went to other facilities. Mayor Stringfellow wanted to know where do we go from here.

City Administrator Jackson stated that the County Supervisor Dr. Frederick was left in the dark. Councilwoman Douglas stated that the newspaper commented that a YMCA presence will continue but not in Chester. Be cautious of putting money in a bad building. Mayor Stringfellow stated that we need to provide recreation to improve the citizens quality of life and there should be a commitment to the residents. Councilwoman Douglas brought up revenues from the City and the County.

Councilman Killian stated that the City of Chester should have received information regarding revenue. Councilman Killian said we should work together to move the project forward. Councilman Killian, we need a collateral effort and a partnership stated that programs have gone down, we need fund raising, help from industries. He stated that we got to do something and agreed by Mayor Stringfellow. City Administrator Jackson stated the City of Chester got crumbs for the penny sales tax. Director White stated that we need to keep the building in the City.

Upon motion made by Councilwoman Kovas and seconded by Councilwoman Campbell to appoint an Ad Hoc Committee, Council voted [6- Mayor Stringfellow, Councilmembers TaTanish Campbell, Annie Reid, Susan Kovas, William Killian, Angela Douglas, and Robin King-Boyd to accept the recommendation for an Ad Hoc Committee for the YMCA. Opposes none.
